Meeting was called to order by Mary Koebrich @ 7:00P M. Mary Koebrich and Steve Cooney made a 1st and 2nd to approve the minutes from September 25, 2018. Motion passed 4.0

Mary Koebrich welcomed everyone and the Board introduced themselves and each homeowner gave their name and address. There were 36 homeowners in attendance.

Treasurerøs Report:

Steve Cooney reported that the General Fund had \$66,142.31 and the Reserve Fund had a balance of \$359,564.33 as of September 30, 2018. In addition there are the CDøs on deposit expiring anywhere from April 23, 2019 to July 20, 2023.

Finance Report:

Steve Cooney reported that the total income for September was \$18,152.33 and the expenses were \$19,814.30. Net income through September 30, 2018 was a negative number of \$1,661.97. The reason being is that we had major tree pruning of (\$6,996.) and legal fees of (290., and a reserve study update of (\$550.), and federal income tax payment of \$\$253.) All the homeowners were given a copy of the financial report.

Neighborhood Report:

Mary Koebrich announced she has received a copy of the report.

Mary Koebrich made a motion and Jan Swanson made the 2^{nd} to approve Danuta Hall to fill out the term of Bob Baechold, who recently moved to a retirement facility. Motion passed 4.0

Architecture Committee:

Representing the Quail Run Board (which serves as the Architecture Committee) Mary Koebrich announced there had been no requests from Homeowners to remodel or change anything regarding their personal residence.

Emergency Preparedness Committee:

Kathy Tomlanovich passed out a flyer from FEMA Her assistants Shiela Pardee and Donna Samson kept us posted thru the Newsletter while Kathy was away. They will be meeting very soon. Kathy also thanked the Board for their ongoing support of the committee. Kathy mentioned that after talking to several doctors in our neighborhood, that we should use our Club House as the command center for folks who might be injured, but more seriously injured will be transported to RiverBend Hospital. She encouraged all of us to read the monthly Letter, because that is where updates from the committee will be.

Events Committee:

Addendum to Finance Committee Report:

Steve Cooney explained where our \$160. monthly Homeowner Fee is spent monthly. The largest numbers are administration, garbage/recycling, and the ongoing contract with Rexius for landscaping. Homeowners were given a copy of Profit and Loss Budget from January 2018 thru September 2018.

A question from the audience asked if an increase to our H O dues would be in the near future. The answer from Steve Cooney was not in the near future, but he said that is a subject that the Board should keep an eye on. We are doing fine currently with the existing fee.

Landscaping Committee:

Bob Kline our landscape chair is putting together a plan to when someone else takes on the duties of chairperson, they will have specific instructions on how to do this very important job. He is also in the process of asking questions of green grass experts (Oregon State University) that could advise him on our ongoing grass problem on the street homes front yards of Quail Run.

Maintenance Report:
